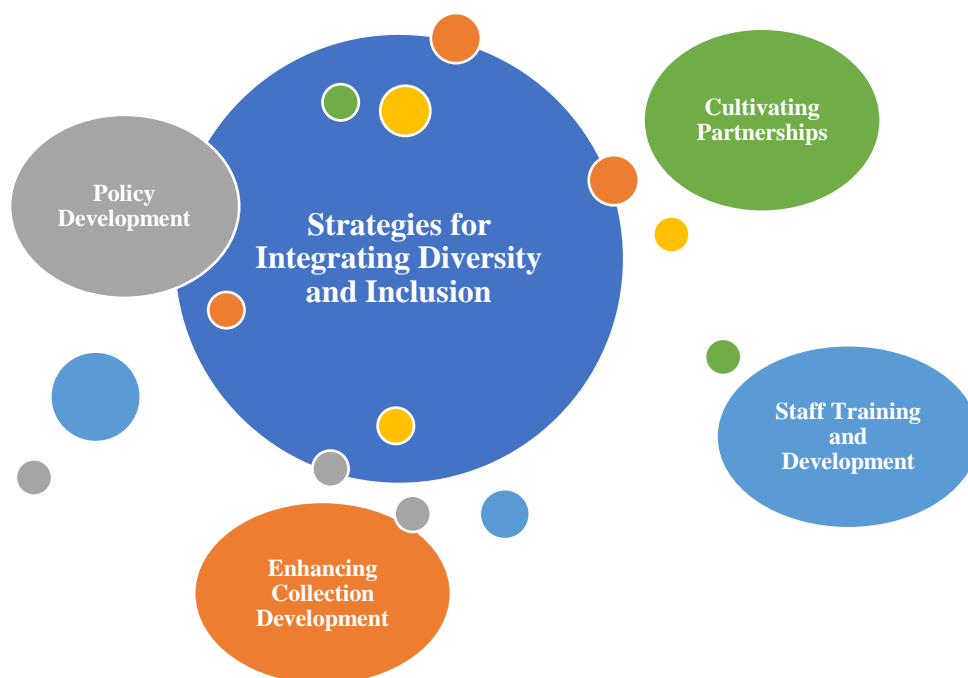


Figure 1: *Strategies for Integrating Diversity and Inclusion*

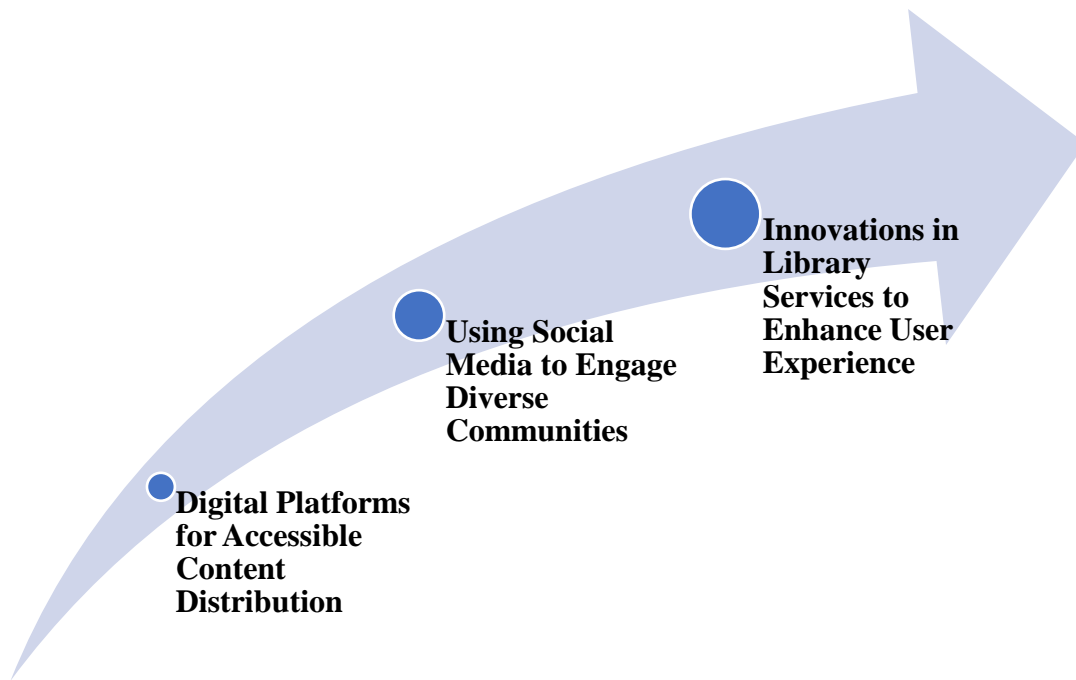


Figure 2: *Leveraging Technology for Inclusive Library Services*

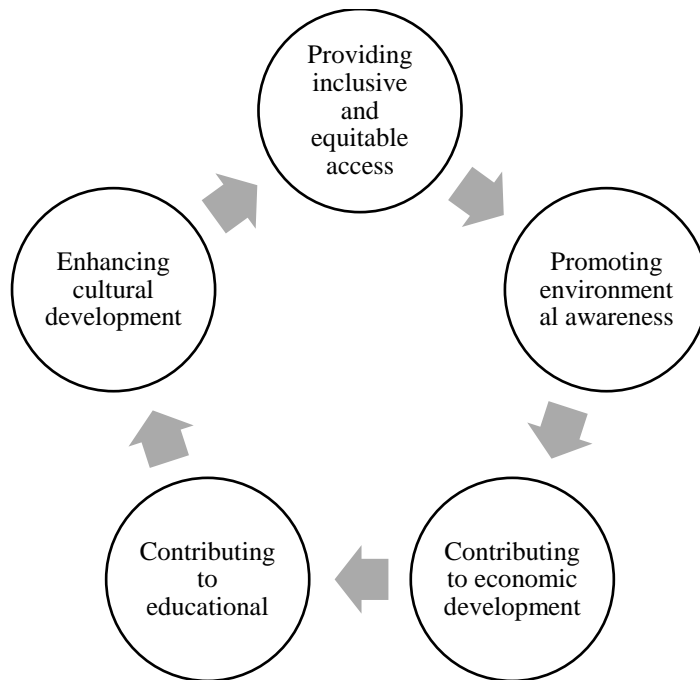


Figure 3: *How Inclusive Library Services can drive Sustainable Development*
